On February 27, 2019, Joel Moskowitz, Ph.D., delivered the keynote presentation, "Cell Phones, Cell Towers and Wireless Safety" for the "Balancing Technology" series offered by University Health Services (UHS) at the University of California, Berkeley. Dr. Moskowitz, director of the UC Berkeley Center for Family and Community Health, has been translating and disseminating the research on wireless radiation health effects since 2009.
